RULE OF 21 1/2

Ron Klinger's Rule of 21 1/2, found in his book When To Bid, When To Pass, is an excellent criterion for opening 1-of-a-suit in first and second seat. You might not agree with its conclusion in some cases, and no mechanical method can eliminate the need for judgment. However Klinger's rule is far better than the familiar opening criterion of 13 HCP's. It is also significantly better than Marty Bergen's Rule of 20, introduced in his book Points Schmoints.

Rule of 21 1/2 for Opening 1-of-a-suit

HCP + lengths of two longest suits + number of quick tricks must be at least 21 1/2.

Whether you adopt this rule or not you should be aware of the shortcomings of the usual 4-3-2-1 HCP system. Both experience and computer studies have determined that Q's and J's, when not accompanied by A's or K's, are overvalued at 2 and 1, respectively. This is especially significant for Q's and J's in different suits, but even the combination QJx is worth only 2 HCP rather than 3. (All our stated HCP values are meant to be correct only to the nearest integer). Tens are frequently worth more than 0; for instance the combination QJT is worth 3 HCP. The usual value of a K, 3 HCP, is correct, whereas A's are undervalued at 4. Three A's are easily worth 13 HCP. Finally, you should subtract 1 point for unguarded honors in short holdings: KQ = 4, KJ = 3, K = 2, QJ = Qx = Q = 1, Jxx = Jx = J = 0

As for quick tricks, recall that the complete list is AK = 2, $AQ = 1 \frac{1}{2}$, A = 1, KQ = 1, $Kx = \frac{1}{2}$.

Examples of the Rule of $21 \ 1/2$

AQJxx-QJTxx-xx-x: 10 + (5 + 5) + 1 \frac{1}{2} = 21 \frac{1}{2}. Open. AJxxx-AJxxx-xx-x: 10 + (5 + 5) + 2 = 22. Open. Kxx-Ax-Axx-xxxxx: 11 + (5 + 3) + 2 \frac{1}{2} = 21 \frac{1}{2}. Open. x-QJTx-xxx-AKxxx: 10 + (5 + 4) + 2 = 21. Pass. KJx-QJTx-QJT-QJT: 13 + (4 + 3) + \frac{1}{2} = 20 \frac{1}{2}. Pass. xxxx-xxxx-AKx-Ax: 11 + (4 + 4) + 3 = 22. Open. AJxxx-KJxxxx-x-x: 9 + (5 + 6) + 1 \frac{1}{2} = 21 \frac{1}{2}. Open. AQxx-Qx-KJxx-xxx: 11 + (4 + 4) + 2 = 21. Pass. QJTxx-AQTxxx-x-x: 9 + (5 + 6) + 1 \frac{1}{2} = 21 \frac{1}{2}. Open.
